

- 1. Bids can be placed online at www.90sAuctions.com by registered bidders, or by phone at (224)422-2273. Phone bids will be made by proxy, by 90s Auctions, LLC staff acting on your behalf as quickly as possible.
- 2. A buyer's premium equal to 17% of the winning bid will be added to all lots. A \$100 winning bidder will thus be charged \$117. Any bidder who elects to pay by PayPal will also be subject to a 4% convenience charge. This fee applies only to payments made by PayPal (including credit card payments made through PayPal).
- 3. BIDDING: Bidding begins immediately upon the launch of the auction on our web site. Preliminary bidding will end at 8:00 PM Eastern Time on the auction closing date. At 8:00 PM Easter Time, the entire auction will enter extended bidding. You must place a bid on any lot prior to 8:00 PM Eastern Time to participate in extended bidding
- a) Online Bidding Online bidding for registered users who have obtained a User ID and Password is available 24 hours, 7 days a week. Beginning at 8:00 PM Eastern Time on the auction closing date, bidding will be extended in accordance with the terms of the "15-Minute Rule" (with all items ending at the same time). After 8:00 PM Eastern Time, "Time Left" in the user interface will count down time remaining, and the auction will extend until no lot in the entire auction receives a bid in a 15m interval, at which time the auction will officially close and "Time Left" will read "Auction Has Ended." Please note, after 2AM ET we reserve the right to close the auction without warning.

b) Telephone Bidding - Telephone bids will be accepted between 9:00 AM and 9:00 PM, Eastern Time, 7 days a week, except for the auction closing date when bidding will continue until 8:00 PM Eastern Time and then for an indeterminate period in accordance with the "15-Minute Rule." The auction will close once no bids are received either online or through telephone bids.

Winning bids will be subject to additional charges for packing, shipping and insurance. We try and keep shipping fees as low and reasonable as possible.

4. SHIPPING SCHEDULE: A fee of \$15 per invoice valued up to \$750; \$25 per invoice valued between \$751 and \$5,000; \$35 per invoice valued between \$5,001 and \$10,000; \$50 per invoice valued between \$10,001 and \$50,000; and \$80 per invoice valued greater than \$50,001.

There are exceptions to this schedule in instances of shipments outside the continental US, or in the instance of large, heavy or fragile items that require special packing or shipping carrier (i.e., oversized and framed items, large lots or graded sets), or oversized items such as bats. Lots that will have higher than expected shipping will be identified in their descriptions.

- 5. 90s Auctions, LLC charges 7.75% Illinois sales tax on purchases unless we have a valid resale certificate on file. We reserve the right to modify our sales tax policies, even mid-auction, as the laws and our responsibilities are currently changing.
- 6. We accept Paypal, Check or Money Order, Zelle, or wire transfer. We do not accept direct credit card payment, though you can pay by credit card through PayPal. A 4% service charge is applied to PayPal payments.
- 7. 90s Auctions, LLC employees CANNOT see max bids. The firm does not have access to max bids in any way. If you choose to leave a max bid, 90s Auctions, LLC will not know the amount of that bid
- 8. You must be a registered bidder in order to participate in the auction. Visit www.90sauctions.com and complete the bidder registration.

Bidders are required to provide at least two hobby reference to register. Registrations are approved manually. If "eBay" is your hobby reference you must provide your eBay ID. By "hobby reference," we are referring to an individual business entity, such as an auction house with whom you have done business as a buyer. All registrants must be 18 years of age. 90s Auctions, LLC reserves the right to refuse any bidder registration or any consignment, for any reason. Registering to

bid means you agree to these terms and conditions.

- 9. We reserve the right to withdraw any item from the auction at any time during the auction, for any reason. This includes after the close of the auction, if there are issues or questions with title, authenticity, or other issues related to human or mechanical error.
- 10. Your bid is a contract. Once you place a bid, it cannot be retracted. If you have questions about how to bid, please contact us BEFORE YOU BID. Bidder error does not constitute a reason to retract bids, nor does a lack of understanding of the auction rules. You MUST read and agree to these rules prior to placing a bid. If you have a question, please ask before bidding.

- 12. "Max" or "Ceiling" bids can be placed on any lot. They must conform to the proper bidding increment based on a lot's high bid at the time such a bid is placed. In the event of a tie between bids, the earlier bid received will be recognized as the winning bid. If a bidder places a "straight" bid equal to a "max" bid left by someone earlier, the "max" bid will be considered the winner.
- 13. Consignors may not bid on their own materials. 90s Auctions, LLC reserves the right to cancel any bid should we believe that bid was made by a consignor, or representative of a consignor, bidding on his/her own materials. We reserve the right to decline consignments for the same reason, at any point before, during, or even after the auction, if we believe a consignor or his proxy is placing bids on his lots. We take this rule extremely seriously and will enforce it.

- 14. Our auction software generates electronic bid confirmations and outbid notices electronically and automatically. 90s Auctions, LLC cannot guarantee that you will receive the emails or text messages. We recommend checking the status of your bids on the website during the course of the auction.
- 15. Unsold or unpaid lots may be sold privately or re-auctioned at the discretion of the consignor. Should 90s Auctions, LLC pay the consignor for an unpaid lot, 90s Auctions, LLC will own this item and can re-sell it in a future auction.
- 16. If, for any reason, our auction is interrupted during bidding due to unforeseen technical errors, 90s Auctions may choose to extend bidding beyond the stated closing date or time. This decision is at the discretion of 90s Auctions, LLC, and by bidding in our auction, you agree to this. - 17. Payment must be received on all winning bids within 14 calendar days of notification of items won. We appreciate prompt payment so that consignors in turn receive their proceeds. Notifications and invoices are sent by email. This is how 90s Auctions notifies a winning bidder. It is your responsibility to check your account to see if you are a winning bidder. Any bidder not paid in full within 14 days of notification may have future bidding and consigning privileges revoked and will be subject to legal action.

- 19. All items are purchased "AS IS" and may not be returned for any reason. No returns are permitted.

- 23. Bidders and consignors agree, by participating in the auction, that 90s
